Purpose

... to provide guidelines for the allocation of storage space to members for their personal competition equipment

Background

Port Macquarie SLSC encourages members to participate in surf life saving competition. For that purpose many members purchase their own equipment. The Club acknowledges that by allowing members to store their equipment in Club facilities encourages use of that equipment for training and competition purposes.

Responsibilities

The Club Captain has overall responsibility for the equipment stored in Club facilities.

The Gear Steward has responsibility for ensuring all PM SLSC equipment is appropriately stored and cared for.

Members are responsible for ensuring they follow this procedure and any reasonable condition placed upon the storage of personal equipment by the Gear Steward.

Procedure

1. Only members of PM SLSC may store personal equipment within Club facilities unless otherwise agreed by the Management Committee.
2. To use store personal equipment in Club facilities, members must meet the following conditions
 - a. Be a current financial active member
 - b. Be approved to store equipment by the Club Captain, Gear Steward or the Management Committee
3. No responsibility is taken by the Club for loss or damage to personal equipment stored in Club facilities
4. Members may only store their equipment in the rack/space allocated to them. The storage racks will be allocated by the Gear Steward or Club Captain.
5. At the beginning of each season, expressions of interest in storage of personal equipment will be sought and allocation of storage spaces made by the end of October

6. Members can seek permission to store personal equipment in Club facilities at any time.
7. The right to store equipment is for the current season only. Each season, members must seek permission again. If permission is not granted they must remove their personal equipment within 7 days of being asked to do so by the Club Captain or Gear Steward.
8. The Club reserves the right to ask any member to remove their personal equipment from Club facilities at any time. Such request may come from the Club Captain, Gear Steward or the Management Committee.
9. Where there is more demand than space for storage of personal equipment, the Club Captain and Gear Steward shall use the following points system to determine who has first priority.

Patrol-related points

- a. Current season –
 - i. rostered, Life member, long service or Active Reserve status = 2pt
- b. Last season –
 - i. Rostered and attended 100% patrol = 4pt
 - ii. Rostered and attended between 50% & 100% patrol = 3pt
 - iii. Life member , long service or Active Reserve status = 3 pt
 - iv. Life Member, long service or Active Reserve status and 20+ patrol hours = 4pt

Competition-related points (branch carnivals, country, state or national)

- a. Last season –
 - i. Competed on the type of equipment that wants to store = 8pt max
(2 pts per carnival to a maximum of 8pts)
 - ii. Competed in other events = 2pt
- b. 2 seasons ago –
 - i. Competed on the type of equipment that wants to store = 8pt max
(2 pts per carnival to a maximum of 8pts)
 - ii. Competed in other events = 2pt
